Text SIGN SEUDKP to 50409 to sign “Ending Qualified Immunity Act” and deliver it your officials

- Qualified Immunity is a legal doctrine that shields government officials from being sued for discretionary actions performed within their official capacity, unless their actions violated “clearly established” federal law/constitutional rights. So, plaintiffs have to show not only that their rights were violated, but also that the officer’s conduct had been clearly addressed in a similar previous case and found to be unconstitutional. If no previous case involving the disputed conduct exists, as happens with a lot of cases, the officer is immune.
